**WHEREAS**, females between the ages 16-24 are more vulnerable to intimate partner violence than any other age group at a rate almost triple the national average; and

**WHEREAS**, one in three adolescent girls in the United States is a victim of physical, emotional, or verbal abuse from a dating partner, a figure that far exceeds victimization rates for other types of violence affecting youth; and

WHEREAS, high school students who experience physical violence in a dating relationship are more likely to use drugs and alcohol, are at a greater risk of suicide, and are much more likely to carry patterns of abuse into future relationships; and

WHEREAS, only 33% of teens who were in an abusive relationship ever told anyone about the abuse, and 81% of parents surveyed either believe teen dating violence is not an issue or admit they do not know if it is one; and

**WHEREAS**, by providing young people with education about healthy relationships, and by changing attitudes that support violence, we recognize that dating violence can be prevented; and

**WHEREAS**, the establishment of Dating Violence Awareness and Prevention Month will benefit teens, their families, schools, and communities regardless of socioeconomic status, ethnicity, or gender.

At the same time, I feel driven to do all that I can to help raise awareness about the serious issue of dating abuse and launched StopDatingViolence.org. In preparation for this month's observance of Dating Violence Awareness & Prevention Month, I have mailed out over 250,000 FREE wallet-sized Dating Pledge Cards (in English and Spanish) to high schools, colleges, and domestic violence agencies in all 50 states. The feedback has been tremendous. School counselors, health teachers and domestic violence advocates who present to schools are finding the cards to be a valuable tool in helping them to begin a conversation and raise awareness about dating abuse and healthy relationships in their work with young people.

I'll also forward it on to the schools and agencies in your area that are planning activities during the month. 


